### ORDER

As per the Government Order read above, Government have issued orders revising the pension and other related benefits in respect of University Pensioners. Government are now pleased to issue the following modifications against the paras noted below of the Government order read above.

**1. Para 2.3 is substituted by the following :**

"In the case of employees who retired from service on or after 01.07.2014 and whose pre-revised pay forms part of average emoluments for pension, their pay in the pre-revised scale may be enhanced notionally by adding DA at 80%. In the case of those having the eligibility of full pension, and if the pension calculated at the time of retirement is less than 50% of the revised scale of pay from which they retired, 50% of the minimum of the revised scale of pay (Minimum Assured Pension) will be ensured. For those who are not eligible for full pension, the proportion of full pension based on the length of qualifying service shall be ensured. The above provision is not applicable in respect of whom pre-revised pay forms part of average emoluments consequent on availing LWA during the last ten months of service."

**2. Following para is added at the end of para no.2.4**

2.5. The minimum/maximum pension,DCRG, Commutation, Medical Allowance shall be fixed as per the state pension rules for those who come under UGC/AICTE/MES.

**3. Following para is added at the end of para no.6.1**

6.2 Pensioners who retired after 01-07-2014 coming under UGC/AICTE/MES scales of pay are eligible for the enhancement of the limit from Rs.7,00,000/- to Rs. 14,00,000/-

**4. The rate of dearness relief in para no. 7 of Government Order read 1<sup>st</sup> above is made applicable to the Ex-gratia/Family Pensioners of Universities.**
