Farook College **ORDER**

As per the Government Order read 1st above, Government have inter alia issued orders enhancing the existing rate of Dearness Relief payable to State Service Pensioners and Family Pensioners (whose pension/family pension has been revised as per G.O.(P) No.9/2016/Fin dt.20.01.2016) from 6% to 9% with effect from 01.01.2016.

In Para 10.1 of the Government Order read 2nd above, it is ordered that Ex-gratia pensioners/Ex-gratia Family pensioners shall be eligible for Dearness Relief. It has been brought to the notice of Government that the enhanced rate of Dearness Relief sanctioned vide Government Order read 1st above was not granted to Ex-gratia pensioners/Ex-gratia Family pensioners.

Government have examined the matter in detail and are pleased to order that the Ex-gratia pensioners/Ex-gratia family pensioners(whose pension/family pension has been revised as per G.O.(P) No.9/2016/Fin dated.20.01.2016) will also be eligible for enhanced Dearness Relief @ 3% with effect from 01.01.2016, as sanctioned to State Service Pensioners and Family Pensioners vide para 2 (x) of G.O read 1st above, subject to the conditions stipulated therein.


