Pension-Revision of pension in respect of non-UGC teachers retired prior to 01.01.1986 - Clarification - Orders Issued.

ORDER

As per Government Order read above, Government have ordered that non-UGC teachers (excluding 60 opted teachers) who retired prior to introduction of the UGC scheme from institutions where the said Scheme was implemented with effect from 01.01.1986 were granted pensionary benefits under the above scheme with prospective effect as per the provisions applicable in this regard. It was also ordered that the enhanced monetary benefits will be paid with effect from 01.04.2015 and no arrears shall be paid.

- 2.The Accountant General vide letter referred 2nd above sought clarification on the mode of fixation of pension, evolution of pay scales, modalities and mechanism for implementing revision, whether a drop in pension emoluments is to be protected and whether teachers under the Directorate of Medical Education comes under the words 'non-UGC' teachers.
- 3.The Accountant General vide letter referred 3rd above sought clarification whether the benefit contemplated in Government Order read 1st above is applicable to those college teachers who have opted Chapter III of the Pension Statutes 1976 and allowed to continue up to the age of 60 years and retired from service prior to 01.01.1986.
- 4.Government after examining the matter are pleased to clarify the following:

(a). Revision of Pension in respect of those who retired prior to 01.01.1986.

Pension in respect of those who retired prior to 01.01.1986 shall be arrived at 50% of the minimum of the revised scale of the post suggested at Schedule I and II together with Academic Grade Pay (AGP) for the post +DR at Central rates, provided he/she has qualifying service of 30 years or more, in case of others with qualifying service of less than 30 years, pension proportionate to the qualifying service alone will be admissible.

(b).Revision of Family Pension in respect of those who retired/expired while in service prior to 01.01.1986.

Family pension of those who retired/expired while in service prior to 01.01.1986 shall be 30% of the minimum of the corresponding revised scale of the post as suggested at Schedule I and II together with Academic Grade Pay (AGP) for the post +DR at Central rates, provided he/she has qualifying service of 30 years or more,in case of others with qualifying service of less than 30 years, family pension proportionate to the qualifying service alone will be admissible.

- (c)If any drop occurs to any pensioner on the total amount(Basic Pension + Dearness Relief) consequent on fixing pension as per this order, such pensioners shall be given option to draw pension fixed on the state scales. The option form is given as APPENDIX II.
- (d)The benefit contemplated in the Government Order read 1st above is not applicable to teachers under the Directorate of Medical Education and those college teachers who have opted Chapter III of the Pension Statues,1976 and allowed to continue up to the age of 60 years and retired from service prior to 01.01.1986.
- (e)For fixation of pension as per Government Order read above the post of Tutors/Demonstrators is considered equal to the post of Assistant Professor and pension shall be fixed accordingly.
