Revision of Pension and Family Pension in respect of those coming under UGC/AICTE/MES – Arrears on account of revision sanctioned with effect from 01.07.2009 – Orders issued.

### ORDER

1. Consequent on revision of scale of pay, Pension and other related benefits of those coming under UGC/AICTE/Medical Education Scheme were revised vide Government Order read as 1<sup>st</sup> paper above with monetary benefit from 01.03.2010.

2. Several representations have been received by Government requesting to grant arrears of pension, on account of revision ordered in the Government Order dated 07.05.2011, from the date on which revised scale of pay came in to force.

3. Government have examined in detail the various aspects involved in this matter. Eventhough scales under Central schemes are revised once in 10 years, as a practice State pension revision is being extended to pensioners covered under Central schemes each time when pension is revised in respect of State

service pensioners. Accordingly the State pension revision with effect from 01.04.2005 has also been extended to them vide Government Order read as 2<sup>nd</sup> paper above. Since the State pension revision was ordered with effect from 01.07.2009, Government are pleased to sanction the arrears consequent on revision of pension vide Government Order read 1<sup>st</sup> paper above with effect from 01.07.2009.


