**ORDER**

1. As per the Government Order read above Government have clarified that Special Pay sanctioned to various posts in Pay Revision 2009 are Special Pay in lieu of Higher Time Scale of Pay and hence shall be counted for calculating/revising pension irrespective of date of retirement. But in the Government orders issued consequent to orders of Pay Revision 2009 as a part of modification/rectification of anomalies crept in the Pay Revision, Special Pay sanctioned to various posts include Special Pay other than Special Pay in lieu of Higher Time Scale of Pay also.

2. In the circumstances stated above Government are pleased to modify the Government Order dated 04.06.2012 to the following extent:

'The Special Pay sanctioned to various posts in Pay Revision 2009 shall not be reckoned for calculating/revising pension unless otherwise

specified the same as Special Pay in lieu of Higher Time Scale in the Government Order concerned.'

These orders will have effect from 01.07.2009.
