Dated, Thiruvananthapuram, 2nd September, 2013. G.O. (P) No. 415/2013/Fin.

S. R. O. No. 722/2013.-In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:-

RULES

1. Short title and commencement.-(1) These rules may be called the Kerala Service (Eighth Amendment) Rules, 2013.

(2) Save as otherwise provided in these rules, in rule 2,-

(i) sub-rule (1) shall be deemed to have come into force on the 22nd day of March, 2012;

- (iii) clauses (a) and (b) of sub-rule (3) shall be deemed to have come into force on the 1st day of April, 2012;
- (iv) clauses (c) and (f) of sub-rule (3) shall be deemed to have come into force on the 1st day of July, 2009;
- (v) clauses (d) and (e) of sub-rule (3) shall be deemed to have come into force on the 1st day of July, 2011.
- 2. Amendment of the Rules .- In Part III of the Kerala Service Rules,-

(1) in rule 63, in Note 9, for the words and figures "55 years/60 years", the words and figures "55 years/56 years/60 years" shall be substituted;

(2) in rule 68, for the figures and word "3.30 lakhs", the figure and word "7 lakhs" shall be substituted;

(3) in rule 90,—

- (a) in sub-rule (4),---
 - (i) in the first proviso, in the brackets, before the figures and word "65 years", the figures and words "63 years in the case of those who retired at the age of 56 years", shall be inserted;
 - (ii) in the Note to the provisos, after the figures and words "30th day of June, 1980", the words and figures "and in the case of those who retire at the age of 56 years, the said provisos shall take effect on and from the 1st day of April, 2012." shall be inserted;

(b) in sub-rule (4A), for the words and figures "or till the date on which the deceased employee would have attained the age of 62 years, 65 years or 67 years as the case may be in respect of those who retire at the age of 55 years, 58 years or 60 years respectively", the words and figures "or till the date on which the deceased employee would have attained the age of 62 years, 63 years, 65 years or 67 years, as the case may be, in respect of those who retire at the age of 55 years, 56 years, 58 years or 60 years, respectively", shall be substituted;

(c) in sub-rule (4CC), clause (4) shall be renumbered as clause (5) and before clause (5) as so renumbered, the following clause shall be inserted, namely:—

"(4) The normal rate of family pension with effect from the 1st day of July, 2009 shall be 30% of the pay at the time of retirement/death while in service subject to minimum of $\overline{\mathbf{x}}$ 4500 per month and maximum of $\overline{\mathbf{x}}$ 17960 per month (i.e., 30 % of maximum of the highest scale of pay in the State Government Service).";

(d) in sub-rule (6), in Note 5, for the figure "6,000", the figure "15,000" shall be substituted;

(e) in sub-rule (6A), in clause (1) for the figure "6,000", the figure "15,000" shall be substituted;

(f) in sub-rule (7),—

(i) in sub-clause (a) of clause(b), for the figures, symbol and letters "150% of ₹ 33,750 viz., ₹ 16,875", the figures, symbol and letters "50 % of ₹ 59,840 viz., ₹ 29,920" shall be substituted;

(ii) in sub-clause (b) to clause (b), for the figures, symbol and letters "30 % of ₹ 33,750 viz., ₹ 10,125", the figures, symbol and letters "30% of ₹ 59,840 viz., ₹ 17,960" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Various limits applied so far in respect of maximum and minimum amount of pension, maximum Death cum Retirement Gratuity admissible etc. have been enhanced consequent to revision of pension ordered vide G O. (P) No. 87/2011/ Fin., dated 28th February, 2011. As per G O. (P) No. 170/2012/Fin. dated 22nd March, 2012, Government have enhanced the age of superannuation of State Government employees and teachers from 55 years to 56 years. The time period stipulated for getting family pension at higher rate has also been modified vide G O.(P) No. 435/2012/Fin., dated 1st August, 2012. Government, as per G O. (P) No. 326/2011/Fin, dated 2nd August, 2011, read with G O. (P) No. 478/2011/Fin. dated the 24th October, 2011, have enhanced the income limit mentioned in sub-rule (6) of rule 90, Part III of the Kerala Service Rules. To give statutory validity to the above Government Orders, the Government have decided to amend the rules concerned in Part III of the said Rules.

The Notification is intended to achieve the above object.
