## Abstract

KSRs, Part III Rule 100 – Re-employment pay of pensioners coming under UGC/AICTE/Medical Education Schemes - Orders issued.

> As per clause (i) of the Government Order read 1<sup>st</sup> modified vide that read as 2<sup>nd</sup>, Government have issued orders regarding the method of updation of re-employment pay of those retired from State Service prior to 01.07.2009 and subsequently re-employed. Further it was stated that the Principle in general will be applicable to all pensioners on re-employment who were drawing scales of pay under different schemes such as UGC, AICTE, MES etc. But the method of updation in the above cases was not specified anywhere in the order.

> In the circumstance, Government have examined the matter in detail and are pleased to issue the following clarification;

> In the case of pensioners on re-employment who were drawing scale of pay under different schemes such as UGC, AICTE, MES etc., those who retired prior to 01.01.2006 and subsequently re-employed, their reemployment pay will be revised by merging 50% of DA alongwith their basic pay at the time of retirement or the corresponding basic pay introduced with effect from 01.01.1996 as the case may be; and allowing fitment benefit of 24% to the above emolument and if the calculated value thus arrived is less than the minimum of the revised pay of the respective post in the pay band from which the re-employed pensioner retired, it shall be stepped up to the minimum of the corresponding revised pay of the respective post in the pay band at the time of retirement and the revised

re-employment pay will be arrived at by deducting basic pension (prerevised) from it. Re-employed pensioners shall be eligible for AGP of the post from which the pensioner retired and arrears of revised re-employment pay together with admissible DA etc with effect from 01.01.2006.
