S. R. O. No. 181/2013.—In exercise of the powers conferred by sub section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

#### RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (5th Amendment) Rules, 2013.
- (2) They shall be deemed to have come into force on the 7th day of January, 2013.

2. Amendment of the Rules.—In Part III of the Kerala Service Rules, in sub-rule (a) of rule 1, before the existing proviso, the following proviso shall be inserted, namely:—

"Provided that the rules in this part shall not be applicable to the employees appointed on or after the 1st day of April, 2013."

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 20/2013/Fin. dated 7th January, 2013, the Government have decided to implement the National Pension System with effect from the 1st day of April, 2013 in respect of all appointments made on or after the 1st day of April, 2013. To give statutory validity to the above Government Order, the Government have decided to amend Part III of the Kerala Service Rules.
