#### ORDER

Government, as per the order read above, have issued orders implementing 6<sup>th</sup> UGC Pay revision and Scheme for teachers in Universities, Affiliated Colleges, teachers in Law Colleges, Engineering Colleges, Kerala Agricultural University and teachers in Physical Education and qualified Librarians. In the above order , inter alia, it was ordered that the revised pay shall be paid from the month of march 2010 and the pay revision arrears from 1.1.2006 to 28.2.2010 shall be released subject to Central Government agreeing to grant 80% as financial assistance.

Government of India in the letter read above have conveyed their decision to sanction reimbursement of 80% of central share of the additionality of payment of arrears, for the period from 1.1.2006 to 31.3.2010 in 2-3 installments after the State Government have made the payment and subsequent to submission of necessary Undertaking in this regard.

In view of the Government of India decision, Government have examined the matter. It is estimated that an amount of ₹998,46,27,006/-(Rs.Nine hundre) and Ninety eight crores forty six lakhs twenty seven thousand and six only) will be the actual commitment to Government by virtue of implementation of the UGC Pay revision in the State for the

period from 1.1.2006 to 31.3.2010. Government had already submitted the details of expenditure to be incurred to Government of India.

Accordingly ,Government have now decided to disburse the arrears on account of 6<sup>th</sup> UGC Pay revision in 4 (four) installments (namely 1.1.2006 to 30.6.2007, 1.7.2007 to 30.6.2008, 1.7.2008 to 30.6.2009 and 1.7.2009 to 31.3.2010). Government are, therefore, pleased to accord sanction for the release of an amount of Rs.314,08,68,936/- (Rs. Three hundred and fourteen Crores eight lakhs sixty eight thousand nine hundred and thirty six only) being the first installment of arrears for the period from 1-1-2006 to 30-6-2007 and order that for those teachers in service the arrears will be credited to their Provident Fund Account and it will be paid in cash to the retired teachers.

The income tax payable on the arrears shall be adjusted from the arrear salary bills.
