DEARNESS ALLOWANCE TO STATE GOVERNMENT EMPLOYEES AND TO THE TEACHERS COMING UNDER UGC/AICTE /MEDICAL EDUCATION SCHEMES - DEARNESS RELIEF TO STATE GOVERNMENT PENSIONERS AND FAMILY PENSIONERS INCLUDING THOSE COMING UNDER UGC/AICTE/MEDICAL EDUCATION SCHEMES AND THOSE DRAWING DEARNESS RELIEF AT CENTRAL RATES WITH EFFECT FROM 01.01.2011 - MODIFICATION ERRATUM-ORDERS ISSUED.

#### **ORDER**

As per the Government Order read above, Government have issued order revising the Dearness Allowance to state government employees and to the teachers coming under UGC/AICTE/MES, dearness relief to state government pensioners and family pensioners including those coming under UGC/AICTE/MES and those drawing dearness relief at central rates with effect from 01.01.2011. The above Government Order was uploaded in the official website of Finance Department, Government of Kerala.

- 2. On scrutiny it was found that some errors had inadvertently crept in the above Government Order. Government are now pleased to make the following corrections/modifications to the above Government Order uploaded in the official website.
- 3. Para 9 (b) (1) may be read as "The arrear for the period from 01.01.2011 to 31.03.2011 will be drawn and credited to the PF account of the employee along with the salary bill for the *month of April*, 2011 to October, 2011."
- 4. Para 9 (e) may be read as "For claiming the salary for the month of *November 2011*, a certificate shall be attached to the salary bill to the effect that "The arrears as per DA revision from 01.01.11 to 31.03.11 have been claimed and credited to the PF account of the employee."
  - 5. Para 12 of the Government Order stands modified as follows:

"Government are also pleased to revise the rate of Dearness Relief with

effect from 01.01.2011 to State Service Pensioners and Family Pensioners whose pension/family pension has been revised as per G.O.(P) No.87/11/Fin, dated 28.02.2011 as follows"

#### 6. Para 13 of the Government Order stands modified as follows:

Government are also pleased to revise the rate of Dearness Relief with effect from 01.01.2011 to State Service Pensioners and Family Pensioners whose pension/family pension has not undergone revision as per GO(P)No.87/11/Fin dated 28.02.11, and also to the Pensioners/Family Pensioners coming under UGC/AICTE/Medical Education Schemes (who retired prior to 01.07.2004 and whose family pension has been revised as per G.O.(P) No.81/07/Fin. dated 28.02.2007) as follows:

# 7. Para 15 of the G.O stands modified on the basis of the G.O.(Ms)No.413/2010/GAD dated 27.12.2010 as follows:-

The pension structure of Ex-Chairman and members of Kerala Public Service Commission had been modified and the rate of Dearness Relief admissible to them has been changed vide GO(Ms)169/2009/GAD dated 16.07.2009. The rates of Dearness Relief payable along with pension to different categories of Ex-Chairman and members are furnished below:

The rates of Dearness Relief admissible with effect from 01.01.2011 to the Ex-Chairman and members of Kerala Public Service Commission who had prior

service under Government and opted pension for combined service who retired on or after 01.01.06, the rate of Dearness Relief will be as applicable to those who retire in between 01.07.04 and 01.01.06 till the issuance of Government Order revising their pensionary benefits.
