KERALA SERVICE RULES, PART III—FAMILY PENSION—SHARING OF FAMILY PENSION AMONG MENTALLY CHALLENGED PERSONS—ORDERS ISSUED

G.O. (P) No. 483/2010/Fin. Dated, Thiruvananthapuram 13th September 2010.

Read:—Letter No. ASH/LLC-KLM/May 2010 dated 15-5-2010 from the Local Level Committee of National Trust for the Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities, Kollam District.

ORDER

As per Rule 90 (7) (ii), Kerala Service Rules Part III, if there are more than one such son or daughter, suffering from disorder or disability of mind or who are physically crippled or disabled, the family pension shall be paid to them in the order of seniority irrespective of sex.

The Local Level Committee of Kollam District of the National Trust for the Welfare of Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities in the letter read above has requested Government to make necessary amendments in Kerala Service Rules so that all challenged siblings are eligible to get equal rights to inherit their parents' pension.

Government, after having examined the matter in detail, are pleased to order that family pension shall be divided equally among those suffering from disorder or disability of mind or who are physically crippled or disabled irrespective of sex.
