Sub:- Unification of date of retirement of Government Employees and Teachers – Submission of pension papers -Instructions- Issued –reg.

Ref: - (1) G.O (P) 154/09/Fin dated 24/4/2009.

(2) D.O. Lr. No. PM/6-44/09-10/27 dated 4/5/09 from the Accountant General (A&E), Kerala, Thiruvananthapuram.

In the Government Order read above, it was ordered that all Government Employees and Teachers who attain the age of 55 years during the course of the financial year will continue in service till the end of that financial year. In the letter read above, the Accountant General (A&E) has pointed out that the immediate fallout of the above G.O will be that the Pension Sanctioning Authorities may stop processing applications of pension cases till the end of the financial year, resulting in a sudden spate of applications at that time. The Accountant General (A&E) has also pointed out that this will place his office functions in considerable difficulty and suggested to advise all Pension Sanctioning Authorities that unless all pension cases are received in his office by 30th September, they will not be in a position to authorize pension before 31st March of the succeeding year,ie., when the Government servants retire.

2. In the above circumstances, all Pension Sanctioning Authorities/ Heads of Departments are directed to prepare pension papers sufficiently early and forward it to the Accountant General well before 30th September every year, so as to enable the Accountant General to authorize pension in time and to avoid hardships to the pensioners.
