## ORDER

In the G.O read above orders have been issued to the effect that all Government employees and teachers who attain the age of 55 years during the course of the financial year will continue in service till the end of that financial year. The extended period of service of Government Employees and Teachers will be reckoned for all service benefits such as Pay Revision, DA revision, Increment, Higher Grade, Promotion, accrual of Leave and for Pensionery benefits.

- 2. Govt. have now decided to extend the benefit of the G.O dated. 24-04-2009 to the following categories also:
  - i) Employees of Public Sector Undertakings/Autonomous bodies, Universities, Corporations & Boards under State Govt.
  - ii) Employees coming under direct payment system in all Aided Schools/Colleges, Technical Institutions and Health Institutions.
  - 3. In the case of autonomous bodies this Order will apply subject to the decision by their governing bodies
  - 4. The above orders will apply only to the employees whose retirement age is 55 vears.
- 5. Necessary amendments to the respective rules will be issued by the concerned departments.
