## <u>Order</u>

As Per Government Order read first above, disabled divorced daughters and widowed disabled daughters were brought under the definition of family under Rule 90(6), Part III, KSRs for entitling them to family pension.

2. The Accountant General in his letter read 4th above, has sought clarification as to whether family pension to widowed /divorced disabled

daughter is to be stopped on earning a livelihood ie; when the annual income exceeds Rs 6000/- as applicable in the case of dependents like parents and unmarried daughters above the age of 25 (vide G.O read 2nd). It has also been informed that Government of India as per the Office Memorandum read third above has prescribed an income limit in such cases.

- 3. Government after having examined the matter in detail order that the annual income limit for getting family pension to divorced disabled daughters and widowed disabled daughters is fixed at a maximum of Rs 6000/- per annum as in the categories of dependents like parents and unmarried daughters above 25 years of age.
- 4. Formal amendment to Rule 90, Part III, KSRs by incorporating a proviso under Rule 90(7) Part III KSRs will be issued separately.
