- G. O. (P) No. 542/2007/Fin. Dated, Thiruvananthapuram, 12th November, 2007.
- S. R. O. No. 936/2007.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala, hereby make the following Rules further to amend the Kerala Service Rules, namely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (Eleventh Amendment) Rules, 2007.
- (2) Sub-clause (ii) of Clause (b) of rule 2 shall be deemed to have come into force on the 24th day of September, 2001 and the remaining provisions of the Rules shall be deemed to have come into force on the 5th day of May, 1979.

- 2. Amendment of the Rules.—In Part III of the Kerala Service Rules.—
 - (a) In rule 63, for the word 'twelve' the word 'ten' shall be substituted;
 - (b) in the Notes below to Rule 63, in Note 3,—
 - (i) for the figures "12" wherever they occur, the figures "10" shall be substituted;
 - (ii) after the existing sentence, the following sentences shall be inserted at the end, namely:—

"For Computation of average emoluments, a calendar month is taken as having 30 days irrespective of the actual number of days in any month including the month of February. For computing emoluments for split days of a month, emoluments is to be calculated as proportionate to emoluments of 30 days".

Explanatory Note

(This does not form part of the notification, but is intended to achieve its general purport.)

As per Rule 63, Part III Kerala Service Rules as existing now, the term average emoluments for purpose of pension means the average of emoluments calculated upon the last twelve months of Qualifying Service. The period of twelve months was reduced to ten months vide G. O. (P) No. 456/79/(41)/Fin. dated 5th May, 1979.

Government vide G.O. (P) No. 1055/2001/Fin. dated 24th September, 2001, have ordered that for computation of average emoluments, a calendar month shall be taken as having 30 days, irrespective of the actual number of days in any month including the month of February. For computing emoluments for split days of a month, emoluments is to be calculated as proportionate to emoluments of 30 days.

In order to give statutory validity to the above orders Government have decided to make necessary amendments to relevant rules in Part III Kerala Service Rules.

This notification is intended to achieve the above object.
