- G. O. (P) No. 541/2007/Fin. Dated, Thiruvananthapuram, 12th November, 2007.
- S. R. O. No. 935/2007.—In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala, hereby make the following Rules further to amend the Kerala Service Rules, namely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (Tenth Amendment) Rules, 2007.
 - (2) They shall be deemed to have come into force on 18th May, 2002.

- 2. Amendment of the Rules.—In Part III of the Kerala Service Rules in Rule 90,—
 - (1) in sub-rule (6) after item (i), the following shall be inserted, namely:—
 - "(j) Disabled divorced daughter.
 - (k) Widowed disabled daughter.";
 - (2) after Note 3, below to sub-rule (6), the following shall be inserted, namely:—
- Note 4:—In the case of disabled divorced daughter of a deceased employee/
 pensioner whose marriage has been legally annulled, family pension is
 admissible from the date on which her marriage stands annulled. In the
 case of widowed disabled daughter of a deceased employee/pensioner,
 family pension is admissible from the date of death of her husband.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government, vide G. O. (P) No. 387/2002/Fin. dated 18th May, 2002, have issued orders amending priority existing under Rule 90 (6) by including disabled divorced daughters and widowed disabled daughters also in the definition of family. It is also ordered that in such cases family pension is admissible from the date on which the marriage gets annulled in the case of disabled divorced daughter of a deceased employee/pensioner and from the date of death of husband in the case of widowed disabled daughter.

To give statutory validity to the above order, Government have decided to make necessary amendments to relevant Rules in Part III Kerala Service Rules.

This notification is intended to achieve the above object.
