REVISION OF EX-GRATIA PENSION TO THOSE RETIRING PRIOR TO 1-7-2004— SANCTIONED—ORDERS ISSUED

ORDER

As per the Government Order read as 2nd paper above, an ad hoc increase of 10% in the pension was sanctioned to all ex-gratia pensioners who retired prior to 1-7-2004. Subsequently, the rates of ex-gratia pension were revised for those who are retiring after 1-7-2004 as per Government Order read as 3rd paper above.

As per the representation read as 4th paper above, ex-gratia pensioners retired prior to 1-7-2004 have requested Government to revise their ex-gratia pension at the same rates as allowed to the ex-gratia pensioners, retired after 1-7-2004.

The Accountant General (A&E), Kerala, Thiruvananthapuram, in his letter read as 5th paper above has suggested to amend the date of effect of the Government Order read as 2nd paper above as on 1-7-2004 so as to enable the ex-gratia pensioners who retired after 1-7-2004 to draw arrears on revised pension with effect from 1-7-2004.

Government, after having examined the request of the ex-gratia pensioners retired prior to 1-7-2004 in detail, are pleased to revise their ex-gratia pension on the same rates as sanctioned to those retired after 1-7-2004, as follows:—

Completed year of qualifying service	Revised consolidated amount (Rs. per month)
9 Years	2160
8 Years	1920
7 Years	1680
6 Years	1440
5 Years	1200
4 Years	960
3 Years and below	720

The above revision will take effect from 1-4-2005 only.

Government have also examined the suggestion of the Accountant General read as 5th paper above and accordingly order that the revision of ex-gratia pension of those retiring after 1-7-2004 will take effect from the date of their retirement.

The Government Orders read as 2nd and 3rd paper above stands modified to the above extent.
