S.R.O NO 634/87- In exercise of the power s conferred by sub -section (1) of section 2 of the Kerala Public Service Act, 1968 (19 OF 1968) read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules , namely -

## RULES

(C.S) NO. 14/1987)

1. Short title and commencement - (1) these rules may be called the Kerala Service (Amendment rules 1987.)
2. They shall be deemed to have come into force with effect from the $13^{\text {th }}$ day of July, 19884.
3. Amendment of the Rules - In part 111 pf the Kerala Service Rule in rule 42, after sub-rule (2) the following sub-rule shall be inserted namely ';-

3 In the case of an employee who is invalidated under this rule irrespective of the length of services , put in by him the actual period of the qualifying service on the intended date of invalidation shall be increased by a period of 5 years subject to the condition that the total qualifying service after allowing the weight age shall not exceed 30 years and the weight age shall not exceed the difference between the age of superannuation and age at the date of invalidation,. Fractions, if any, in the qualifying service so arrived at shall be rounded to the nearest completed year, that is fraction of less than half year shall be ignored and half year and above shall rounded to the next completed year ${ }^{\text {' }}$
