#### ORDER

According to rules 138 and 139 of Part III, Kerala Service Rules, the legal heirs of a deceased pensioner have to produce either a legal authority issued by a Court of Law or a heirship certificate for receiving the life time arrears of pension due to a deceased pensioner. The Government of India in the O.M. referred to above have revised the procedure regarding the payment of life-time arrears of pension due to their pensioners. The Accountant General in the letter read as second paper above has suggested to incorporate a similar provision in the State side also. Government after examining the various aspects are pleased to issue the following revised procedure:

1. A pensioner maximominate any other person, who shall receive after the death of the pensioner all moneys payable to him on account of such pension on, before or after the date of such nomination and which remain unpaid immediately before the death of the pensioner.

(1) Every pensioner who has retired on or before the date of commencement of these rules shall within six months nominated any person in Form A and submit it in triplicate to the respective pension disbursing authority through whom pension is drawn.

(2) Within thirty days of the receipt of nomination in Fc 1 'A s referred to in sub-rule (1) the pension Disbursing Authority shall get use particulars of the pensioner as mentioned in Form 'A', verify with reference to the available records and return to the pensioner after obtaining a receipt thereof, the duplicate copy of the nomination in Form 'A' duly attested by him or an officer authorised by him in this behalf. The triplicate copy shall be sent to the pension sanctioning authority while the original copy of the nomination shall be recorded.

(3) Every employee who is due to retire after the date of commencement of these rules shall submit the nomination in triplicate in Form A to the Head of the Department within three months before or after the date of retirement.

(4) Within thirty days of the receipt of the nomination in Form  $\therefore$  under sub-rule (3), the Head of Office shall get the particulars of the pension  $\cdot$  as mentioned in Form  $\cdot \Lambda$ , verify with reference to the records of the establisment and return to the pensioner, after obtaining the receipt thereof, duplicate copy of the nomination in Form  $\cdot \Lambda^2$ , duly attested by him or by a officer authorised by him in this behalf. The triplicate copy duly accepted shall be sent to the Pension Sanctioning Authority who shall pass it on to the Pension Disbursing Authority along with the Pension Payment Order. If the Pension Payment Order has already been issued in a particular case, the nomination shall be sent separately quoting Pension Payment Order number and other particulars of the pensioner to enable the Pension Disbursing Authority to link it up with the Pension Payment Order.

(5): A notice of modification of nomination including cases where a nominee predeceases the pensioner shall be submitted in triplicate in Form 'B' to the Pension Disbursing Authority in the manner specified in sub-rule (1) and thereafter the provisions of sub-rule (2) shall apply mutatis-mutandis with modifications as if it was made under sub-rule (1).

(6) A nomination or a fresh nomination or a notice of modification of nomination shall be signed by the pensioner or if he is illiterate shall bear his thumb impression given in the presence of two witnesses who shall also sign a declaration to that effect in the nomination, fresh nomination or notice of modification of nomination, as the case may be

(7) Nomination, firesh nomination or notice of modification of nomination shall take effect from the date of receipt thereof by the Pension Disbursing Authority or the Head of O flice, as the case may be  $d_{1,2,2}$ 

3. A nomination made under rule 1 and accepted by the Pension Disbursing Authority or the Head of Office, shall be a conclusive proof with regard to the person nominated to receive arrears of pension of the pensioner under these rules.
